- a. Tobacco tax must pass for there to be NO MORE cuts to mental health and substance abuse services; there was a 7% across the board cut last year and could be up to a 30% cut this year (~\$40 million)
- b. If these cuts happen, there will be many untreated people with mental illness and substance abuse issues on the streets with nowhere to go

b. Marijuana and Synthetics

- a. The Medical Marijuana Legalization forum will be 420 (April 20, 2017), 6-8 p.m. at the Pontotoc Technology Center, Entrance A. Everyone is invited to attend. CEUs for a variety of certifications
